## **Information Concerning the International College Training in Asia July 25-30, 2023**

1. **General:** All training meetings will be held at the Central Taiwan Blending Center, Nantou, Taiwan.
2. **Training:** The subject of the Training will be the same as the July Semiannual Training. All meetings will be conducted in English.
3. **Schedule:** Training meetings will begin on July 25 (Tuesday) through July 28 (Friday), followed by a blending trip from July 28 (Friday) through July 30 (Lord's Day).
4. **Lodging:** Hospitality will be provided from July 24 (Monday) through July 30 (Lord's Day), meals will be provided from the dinner on July 24 to the lunch on July 30.

5. **Transportation:** Airport pickup service will only be available on July 24 (Monday) at Taiwan Taoyuan International Airport. Please book your flight and arrange accordingly.
6. **Registration:** All attendants of the training should complete their registration by April 30, 2023 according to the following guidelines:
  - a. All saints attending the training should be registered corporately by regions or countries (quota for each region or country has been assigned due to limited capacity of 400). Application by individuals will not be accepted.
  - b. All saints should attend both the training meetings and the blending trip. Partial application will not be accepted.

  - d. Each overseas registrant should submit a fee of \$300 USD, which would cover the hospitality during the training and the expenses of the blending trip. The fee is not refundable. The fee should be made by remittance to the following bank account:

7. **Blending trip:** The trip will begin right after the training from the Blending Center:
  - a. The attendants will be divided into 3 groups of church visitation and sightseeing:

Group A (Eastern Taiwan): Taipei, Hualien, including the east coast and Taroko Gorge National Park.  
Group B (Southern Taiwan): Tainan, Kaohsiung, including Kenting National Park.  
Group C (Central Taiwan): Taichung, Nantou, including Sun Moon Lake.
  - b. The transportation to the airport for the return flight will be arranged by the groups respectively on July 30 after the trip.
  - c. The registrants should submit their preferences corporately by region or country. The assignment will be on a first come first served basis.
